ORDERED AND ADJUDGED as follows:

Plaintiff may not present or recover more than the traditional Medicare Rate(s) for any past medical special damages claimed.**
- 2. Plaintiff's Corrected Motion for Reconsideration of Order Striking Plaintiff's Letter of Protection is DENIED.**
