**THIS CAUSE** came before the Court on “Defendant’s Motion in Limine Regarding Section 768.0427,” filed July 11, 2025 (Docket No. 108), and “Defendant’s Motion in Limine Regarding Admissibility of Plaintiff’s Past and Future Medical Expenses,” filed July 31, 2025 (Docket No. 128). The motions were set to be heard on September 15, 2025. Due to the Court granting a continuance of the trial in this matter, the parties agreed to not orally argue these motions but instead rely on their written filings. Having reviewed the motions and Plaintiff’s response, and considered the applicable legal authority, it is hereby **ORDERED AND ADJUDGED** as follows:

- 1) “Defendant’s Motion in Limine Regarding Section 768.0427” is **GRANTED**.
- 2) “Defendant’s Motion in Limine Regarding Admissibility of Plaintiff’s Past and Future Medical Expenses” is **GRANTED** to the extent that Plaintiff must present evidence in accordance with section 768.0427(2)(b)1-3, Florida Statutes. The Court does not read Defendant’s motion as asking the Court to limit the Plaintiff to *only* presenting such evidence.
